<u>Change of name of the Company and consequential amendment in Memorandum of Association and Articles of Association of the Company:</u>

The Members are requested to note that the Board of Directors of the Company on November 15, 2022, approved change of name of the Company from 'IIFL Wealth Portfolio Managers Limited' to '360 ONE Portfolio Managers Limited' and consequential alteration in Articles of Association and Memorandum of Association of the Company, subject to approval from Registrar of Companies and Members of the Company.
